Accessible Voting Tips Are Available for New Jersey Voters



“Vote as if your life depends on it—because it does!” Justin Dart knew from experience the power of public engagement. After all, he led the advocacy movement for the Americans

with Disabilities Act. Some may ask why they should vote in an election that does not include the president? First, *every* election is important. Second, in the 2023 general election, **all the state legislature seats—the state Senate and Assembly—will be on the ballot.** The decisions of these elected officials affect issues (such as New Jersey Medicaid) important to people with disabilities. Local elections are also particularly important, especially for boards of education. Mary Ciccone, Director of Policy at Disability Rights New Jersey, said of voting, “It’s your right. Your vote makes a difference. Be involved in politics.”

When Can I Vote by Mail?

If you applied to [vote by mail](#), you should already have received your ballot. You can use any USPS mailbox for a postmark of no later than November 7 or any secure [ballot drop box](#) by 8:00 p.m. on Election Day (Tuesday, November 7).

If you are not sure whether you are registered to vote by mail, you check your voting status at [Track My Ballot](#). (You will need to create an online account.)

Please note: Your vote-by-mail ballot *cannot* be returned to your in-person early voting poll location or your election day poll location.

When Can I Vote in Person?

If you opt to vote in person, you have two options:

- ***In-person early voting*** at any of your county’s designated in-person early voting locations. In-person early voting locations will be open Saturday, October 28, through Sunday, November 5, 2023. Polls are open Monday – Saturday, 10:00 a.m. – 8:00 p.m.; Sunday, 10:00 a.m. – 6:00 p.m. Please note these locations differ from your scheduled polling location. Check for the locations in your county on the [NJ VOTES](#) web page.
- **Voting on Election Day, Tuesday, November 7**, at your scheduled polling location. You can look up your polling location with the state [Polling Place Search Tool](#). Polls are open 6:00 a.m. – 8:00 p.m.

Accessibility Options for Disabled Voters

Lieutenant Governor Tahesha Way, who oversees the New Jersey Division of Elections, stresses that all New Jersey voters should know they can vote safely and securely. “Disabled voters in New Jersey need to know that they have options to cast their ballot privately and securely,” she said. “We appreciate the opportunity to make New Jersey elections inclusive and accessible.”

Important Numbers to Know

Vote by Mail. Voters who cannot vote via a paper ballot without assistance also have an accessible ballot option for the 2023 General Election. To access this option, a disabled voter should reach out to their County Clerk and say they are unable to complete a paper ballot without assistance and wish to vote, using an accessible vote by mail ballot.



DRNJ Voting: It's Your Right

During National Disabilities Employment Awareness Month, Know Your Rights!



For this, the fourth week of NDEAM, we focus on the laws that protect individuals with disabilities against employment discrimination, from application to termination. Below is information you can use for self-advocacy.

Federal Laws


The [Americans with Disabilities Act \(ADA\)](#) prohibits discrimination against people with disabilities in several areas, including employment, transportation, public accommodations, communications, and access to state and local government programs and services.

New Jersey State Laws

The [New Jersey Law Against Discrimination](#) prohibits discrimination and bias-based harassment based on actual or perceived characteristics, including disability, in all aspects of employment.

The [NJ Equal Pay Act](#) prohibits an employer from paying any employee who is a member of a protected class, including a person with a disability, less than what it pays an employee who is not a member of that protected class for “substantially similar work.”

Anyone experiencing discrimination can file a complaint [Division on Civil Rights](#) at the Office of the Attorney General. Disability Rights New Jersey and the New Jersey Council on Developmental Disabilities have published a handy guide with frequently asked questions.

Stay Insured in New Jersey!



Stay Covered NJ

NJ FamilyCare/Medicaid wants everyone to stay insured in New Jersey. NJ FamilyCare (Medicaid) will mail renewals to all members in the year between April 1, 2023, and March 31, 2024. Members should expect to renew their coverage once a year from now on.

If you receive one of the postcards above from your health plan, your NJ FamilyCare renewal mail will be coming this month.

Front: Don't forget to check your mail.

Back: Your NJ FamilyCare renewal mail is coming very soon.

Please open it and follow instructions right away if you want to keep your health care coverage.

Make sure NJ FamilyCare/Medicaid has your correct mailing address.

Members can confirm or update their contact information by calling NJ FamilyCare, at 800-701-0710 (TTY, 711). NJ FamilyCare will use this information to reach members about their healthcare coverage.

Respond to mail from NJ FamilyCare/Medicaid.

Members need to look for and respond to mail from the State of New Jersey or their local County Board of Social Services. If NJ FamilyCare requests information, they need to respond right away to avoid a gap in their NJ FamilyCare coverage.

Get help completing your renewal if you need assistance.
