Mrs. Scott stated the terms of the superintendent's contract is currently being held until direction is received from the State of New Jersey. She spoke of the Governor's initiative to take \$1B in resources from public schools to give to charter schools, noting the two cannot be compared fairly as standards are very different.
- The public was reminded that School Board Candidate Kits are currently available.
- Mrs. Scott noted the budget was under construction, commenting that it is ineffective to vote "no" on the budget as a recourse against the Board of Education members. This only has a negative effect on the students, not the Board members. She also remarked that the PTA's, the largest child advocacy organization, say the state should distribute resources to all students, not just limit it to certain populations.

S. <u>COMMENTS FROM THE AUDIENCE</u>

- A member of the audience questioned the fire alarm and evacuation of the high school and middle school on January 24. It was clarified that a water pipe had burst, causing the alarm to sound. By law, the students must be evacuated until such time it is deemed safe to return. The administration and staff worked as quickly as possible to return the students to their scheduled classes.
- An audience member supported Mrs. Scott's comments regarding the comparison of charter vs. public schools.
