# **CLOSED SESSION**

Mrs. Van Houwe stated high school students received much more college options and related information this year than in the past.

Mrs. Mastricola stated that Terra Nova results have not been mailed. Dr. Bowen stated the results will be reviewed with Education Committee and the Board. Mrs. Mastricola noted the Middle School schedule is not set in stone.
