  - d) Call for a recess or an adjournment to another time when the lack of public decorum so interferes with the orderly conduct of the meeting as to warrant such action; and
  - e) Waive these rules when necessary for the protection of privacy or the efficient administration of the Board's business.

*Please note that "Comments from the Audience" is not a time for dialogue – it is an opportunity for you to share a comment with the Board of Education. In addition, by law, administrators and Board of Education members are not permitted to publicly discuss personnel matters, student discipline, or other issues requiring confidentiality. **K.1 WHEREAS**, the Jefferson Board of Education, in the County of Morris, New Jersey approves the final 2020-2021 school district budget for submission to the Executive County Superintendent of Schools for review as follows:

**NOW THEREFORE BE IT RESOLVED**, that there should be raised a total General Fund Tax Levy of \$ 44,287,305 and Debt Service \$ 2,325,779 for the ensuing School Year (2020-2021).

**K.2 WHEREAS,** the district has a taxing authority which is comprised of:

**WHEREAS,** The Board has approved that there should be raised for the General Fund a tax levy of \$44,287,305,

**WHEREAS,** the **Banked Cap** will be used to implement revised Curricula for World Language in Grades 6-12, and instructional technology that is critical to educational programs and cannot be deferred or incrementally completed over a longer period of time,

**NOW THEREFORE BE IT RESOLVED** that the Jefferson Board of Education, in the County of Morris, New Jersey includes in the local tax levy the accumulated and unexpired Banked Cap taxing authority of \$260,512.

**K.3 RESOLVED,** school district policy and N.J.A.C. 6A:23A-7.3(a) provides that the Jefferson Board of Education shall establish in the annual school budget a maximum expenditure amount that may be allotted for such travel and expense reimbursement for the 2020-2021 school year; and

**WHEREAS,** maximum expenditure amount allotted for travel and expense reimbursement for the 2019-2020 was \$111,165; and

**WHEREAS,** travel and expense reimbursement has reached a total amount of \$39,341.80 as of March 13, 2020,

**NOW THEREFORE BE IT RESOLVED,** that the Jefferson Board of Education, in the County of Morris, New Jersey hereby establishes the school district travel maximum for the 2020-2021 at the sum of \$107,830, and

**BE IT FURTHER RESOLVED,** that the School Business Administrator shall track and record these costs to ensure that the maximum amount is not exceeded.

**K.4 WHEREAS,** N.J.A.C. 6A:23A:5.2(a) mandates boards to establish annually prior to budget preparation, for public relations and each type of professional service, a maximum level of spending for the ensuing school year; and

**WHEREAS**, beginning on Monday, March 16, 2020, Pomptonian has set up an Emergency Feeding Program for the free and reduced-price students in the District, and

**WHEREAS**, the program was established to fulfill the New Jersey Department of Education's requirement to feed "eligible" students to allow E-learning days to count towards the minimum number of school days, and

**WHEREAS**, the Board's contract with Pomptonian did not anticipate this type of closure and does not properly address this situation, and

**WHEREAS**, Pomptonian continues to incur expenses to support the meal distribution program,

**NOW THEREFORE BE IT RESOLVED**, that the Board affirms the submission of the Emergency Procurement/Contract Modification Request to the New Jersey Department of Agriculture requesting to implement a per-diem management fee of \$350 for the period of time the schools are closed due to the COVID-19 pandemic.

**K.16** Motion to approve resolution opposing delay in transmission of quarterly property tax revenue to school districts, as described below:

**WHEREAS**, Assembly Bill 3902, currently pending in the State Legislature, would authorize the Department of Community Affairs to permit municipalities to delay the transmission of property tax revenues to school districts during gubernatorial-declared emergencies; and

**WHEREAS**, New Jersey's public schools are highly dependent on property tax revenue to support education programs; and

**WHEREAS**, on average, local property taxes constitute close to 60% of public school revenue, with the percentage even greater in a significant number of districts; and

**WHEREAS**, a delay in payments from municipalities would result in a financial crisis for school districts, seriously disrupting the educational process—and bringing it to a halt; and

**WHEREAS**, although public school buildings are closed during the current health emergency, the education of our students is taking place through remote learning and home instruction; and

**WHEREAS**, continued timely transmission of school property taxes is critical for the education process to continue without interruption; and

**WHEREAS**, even though municipalities are designated as the authorities to collect property taxes, these taxes are levied for specific purposes—e.g., municipal, school, county, fire district—and these obligations must continue to be met; and

**WHEREAS**, as currently written, A-3902, which is intended to ease a financial burden on municipalities, would place a severe strain on school districts and the students and families that they serve; and

**WHEREAS**, the Jefferson Township Board of Education recognizes the impact of the current public health emergency on the state and local governments, as well as local school districts, but believes this legislation would worsen the situation for our communities.

**NOW, THEREFORE, BE IT RESOLVED** that the Jefferson Township Board of Education urges the State Senate and the Governor to oppose A-3902; and be it further

**RESOLVED**, that this resolution be delivered to Governor Phil Murphy, State Senate President Stephen M. Sweeney, Assembly Speaker Craig Coughlin; and the 26th Legislative District's representatives in the state Senate and General Assembly; and be it further

**RESOLVED**, that copies of this resolution be sent to the New Jersey School Boards Association.
