• The Board members engaged in a discussion regarding the appointment of assistant coaches for the fall season. Aspects discussed included the uncertainty of returning to in-person learning, the board's fiscal responsibility to the taxpayers, the requirement to fulfill contract obligations, the guidelines set forth by the NJSIAA, the importance of assistant coaches to student athletes and the feasibility of holding postponed fall sports in the spring. A board member also commented on the negotiations related activities and the board attorney advised against publicly discussing negotiation matters.

G. PUBLIC COMMENTS

- A staff member reported the Board never came to the JTEA with negotiations. She also requested 3 years of records of air quality reports claiming the HVAC system was deficient in normal circumstances and claimed that MERV 8 filters are not sufficient against COVID-19. She requested the district reconsider their stance and redirect accordingly.
- An audience member inquired about the plan for air filters.
- An audience member noted there is a fiduciary responsibility to care for children and inquired about the plan for students whose parents have to work.
- An audience member inquired about share time vocational students.
- Several audience members commented on the HVAC systems and filters.
- A staff member advocated for all virtual instruction, reporting that NJ has the highest rate of children getting the virus.
- An audience member commented that as virtual is an option, so too should be in person education.
- An audience member reported that teachers are learning new tools and inquired as to what additional time is being spent learning these tools.

- A staff member noted it is difficult for special needs students to learn online. They also noted that they are an "older" employee and have health issues and are still waiting to hear back regarding their leave request.
- There was additional support for assistance coaching appointments.
- Several staff members commented that they would like to be back in school but that the district needs to upgrade the air filters and more accommodations need to be made.
