**E. SUPERINTENDENT'S REPORT**

- Mrs. Howe reported on the Good News and Progress in our schools.

**F. PRESENTATIONS**

- Dr. Maria Dunbar, Business and Finance Academy Supervisor, Mrs. Jessica Brennan, Multimedia, Broadcasting & Journalism Academy Supervisor, and Mr. Christopher Hiben, STEM Academy Supervisor recognized the newly accepted JTHS Academy students.
- Mr. Jahn Tiger, DECA Advisor, along with DECA Students presented an overview of the DECA program.
- Ms. Charlene Peterson, New Jersey School Board Association Representative presented Board Committee Structure, an overview of how Board Committees function.
- Ms. Margaret Widgren, Principal presented the 2025-2026 Jefferson Township Middle School Schedule and reconfiguration for grades 4 through 8.
- Mrs. Rita Oroho Giacchi, School Business Administrator and Mrs. Jeanne Howe, Superintendent gave a brief 2025-2026 budget update.

Ms. Widgren answered questions from the Board members relating to:

- ❖ 22 minutes of recess each day for grades 4 and 5;
- ❖ Clarification of electives for grade 7;
- ❖ Bell schedules,
- ❖ Grades 4 and 5 will have lockers with no locks near their respective homerooms, while grade 6 will have full locker use.

Mrs. Howe answered board member questions about late buses, sewage treatment plant, referendum procedures and timelines, and nursing coverage. Mrs. Howe noted that questions will be collected and a Q & A document will be developed and shared.

Student Representative Victor Koziol inquired about the student activity participation fees. Mrs. Howe noted any changes would go through the Policy and Personnel Committee.

**G. COMMENTS FROM THE AUDIENCE (on agenda action items only, if applicable)**

- An audience member asked about lunch and recess aides, if fourth and fifth grade students could do both band and choir, if the library books will be separated in the library for the elementary students, and how the school will work with the various PTA's for the elementary grades.
- An audience member inquired about the visit to Orange Avenue School and asked how they manage the student schedules. They also asked when the last referendum was done by the district.

Mrs. Howe again noted the administration will be collecting questions to develop a Frequently Asked Questions (FAQ) document to be shared with the community. She addressed lunch and recess aides that would allow for teacher collaboration and stated the district is following the New Jersey Department of Education code regarding nursing staff at every building.

**H. STUDENT REPRESENTATIVES**

- Student Representative Victor Koziol reported the high school students recently participated in DECA Nationals, Eco Fest, the Buddy Walk, Underclassmen Awards, and the spring concert. He also highlighted upcoming events such as AP testing, the Top 20 dinner, Tulip Trot, the Junior Semi Formal, a blood drive on May 21st, JTHS Art Show, Senior Awards, NJSLA testing, pickleball tournament, and the Senior Prom.

**I. COMMITTEE REPORTS**

- **Education Committee** - Mrs. Grater reported the Committee met on May 5, 2025 and discussed the 2025-2026 revised school year calendar and the 2026-2027 school year calendar, the 2025-2028 Comprehensive Equity Plan, varsity girls’ wrestling cooperative, FUNdations program results, analyzing grades 4 and 5 NJSLA performance after reconfiguration, approval of day field trips, and rescheduling of the June meeting.
- **Building Needs and Finance Committee** - Mrs. Wildermuth reported the Committee met on May 5, 2025 and discussed the 2025-2026 budget updates, planned lease purchase expenditures, reconfiguration updates, personnel updates, historical data of staffing adjustments, Cozy Lake playground equipment, 2026-2027 budget planning, the appointment of a food service management company, and rescheduling of the June meeting.
- **Negotiations Committee** - Mr. Brown noted that a tentative agreement has been reached and the final details are being worked out.
- **Community Relations Committee** - Mrs. Grater reported the Committee met on May 1, 2025 and reviewed the district’s reconfiguration webpage. She noted Ms. Widgren’s presentation, along with a FAQ, would be added to the site. Mrs. Poulas added the public may email questions to her or Mrs. Howe.
- **Morris County School Board Association** - Mrs. Grater reported that Mr. Stewart was honored for his 15 years of service to the Jefferson Township Board of Education, as well as service on the Morris County Executive Committee, at a meeting on May 7, 2025. Mr. Natale noted the Unsung Hero meeting was very meaningful.
- **New Jersey School Boards Association** - Mr. Stewart reported there has been a change in the Delegate Assembly Executive Committee and there are no longer members from Morris County serving on the Executive Committee. Mr. Stewart noted there are three items under review; ESports, Excused absence days for students to explore trades, akin to college visits; and a change in licensing requirements for school nurses. Mr. Natale reported the legislative committee will meet on May 31, 2025.

**K.1** Motion to approve the adoption of the Final Budget for School Year 2025-2026.

*WHEREAS*, the Jefferson Township Board of Education adopted a TENTATIVE budget on March 17, 2025, and submitted it to the Executive County Superintendent of Schools for approval;

*WHEREAS*, the TENTATIVE budget was approved by the Executive County Superintendent of Schools on April 10, 2025;

*WHEREAS*, the TENTATIVE budget was advertised in the legal section of the Daily Record on April 17, 2025;

*WHEREAS*, in the proposed FY2026 State Budget, certain districts had the opportunity to apply to the Commission of Education to increase expenditures, including an allocation of Tax Levy Incentive Aid, in order to satisfy the thoroughness and efficiency standards established pursuant to N.J.S.A. 18A:7F-46;

*WHEREAS*, the Jefferson Township Board of Education is below local fair share and spending below adequacy to be eligible to participate in this program;

*WHEREAS*, Jefferson Township Board of Education is eligible to increase expenditures by \$1,013,250 and qualify for Tax Levy Incentive Aid in the amount of \$48,250, pending approval from the New Jersey Department of Education;

*WHEREAS*, the FINAL BUDGET including the increase in accordance with the tax levy incentive aid was presented to the public during a public hearing held in the Jefferson Township High School Media Center, Oak Ridge, NJ, on April 28, 2025; and

*WHEREAS*, the Board of Education has now determined to make modifications to the Tentative Budget as follows:

*WHEREAS*, the Board has approved that there should be raised for the General Fund a tax levy of \$51,715,917, inclusive of adjustments,

*NOW THEREFORE BE IT RESOLVED*, the Board of Education includes in the Final Budget the adjustment for banked cap in the amount of \$154,313, the adjustment for healthcare costs in the amount of \$676,924, and Tax Levy Incentive Aid of \$1,013,250. The district intends to utilize this adjustment to maintain staffing and curricular expenditures. The Board of Education will incur these expenditures by June 30, 2026, and acknowledges that they cannot be deferred or incrementally completed over a longer period of time.

**K.3** *BE IT RESOLVED*, the Board of Education includes in the 2025-2026 budget a capital reserve withdrawal in the amount of \$500,000 for:

- Partial Funding of the High School Sewage Treatment Plant Project

**K.4** *WHEREAS*, school district policy and N.J.A.C. 6A:23A-7.3(a) provide that the Jefferson Township Board of Education shall establish in the annual school budget a maximum expenditure amount that may be allotted for such travel and expense reimbursement for the 2025-2026 school year;

*WHEREAS*, maximum expenditure amount allotted for travel and expense reimbursement for the 2024-2025 school year was \$102,794; and

*WHEREAS*, travel and expense reimbursement has reached a total amount of \$33,685 as of March 14, 2025,

*NOW THEREFORE BE IT RESOLVED*, that the Jefferson Township Board of Education, in the County of Morris, New Jersey hereby establishes the school district travel maximum for the 2025-2026 at the sum of \$73,473, and

*BE IT FURTHER RESOLVED*, that the School Business Administrator shall track and record these costs to ensure that the maximum amount is not exceeded.
