- Mrs. Mastricola requested that the Board only receive changes and/or new additions to the budget.

- An audience member commented that they prefer the flier being mailed to the homes.
- It was noted that the agenda had not yet been posted on the district website.
- A question was raised regarding foreign language.
- An inquiry was made regarding the cap waiver. It was noted that this is no longer being requested.

- A budget press release was also requested to appear in the Aim newspaper.
