WHEREAS, The Board of Education of the Township of Jefferson in the County of Morris, New Jersey (the "Board") adopted a resolution on April 21, 2014 providing for the acquisition and installation of certain equipment through a lease purchase transaction, authorizing execution of a lease purchase agreement with TD Equipment Finance, Inc. and other related agreements and actions necessary to accomplish the transaction (the "Prior Resolution"); and

WHEREAS, the Board has since determined that the cost of the Equipment will be higher than the original estimates and has determined to authorize a change order and to amend the Prior Resolution to increase the size of the financing;

NOW THEREFORE, BE IT RESOLVED, by the Board of Education of Township of Jefferson in the County of Morris, New Jersey as follows:

Section 1. The Prior Resolution is hereby amended to provide that the Board will enter into the Lease in a principal amount not exceeding \$1,570,000 with an adjustment to the payment schedule as is necessarily in the opinion of the Business Administrator/Board Secretary to meet the new size of the transaction. All other matters set forth in the Prior Resolution will remain the same and continue in effect as set forth therein except to the extent of the new principal amount of the financing and this amendment.

Section 2. This resolution shall take effect immediately.

FACILITIES USE AGREEMENT BY AND BETWEEN THE JEFFERSON TOWNSHIP BOARD OF EDUCATION,

AND

JEFFERSON TOWNSHIP

FOR



THIS FACILITIES USE AGREEMENT ("Agreement") is entered into this _____ day of ______, 2013, by and between the Jefferson Township Board of Education ("Board"), a public body corporate and politic of the State of New Jersey with offices located at 31 Route 181, Lake Hopatcong, New Jersey 07849, and Jefferson Township ("Township"), a body politic and corporate of the State of New Jersey, with offices located at 1033 Weldon Road, Lake Hopatcong, New Jersey 07849.

In consideration of the covenants and promises contained in the Agreement, the Board and Township agree as follows:

RECITALS

WHEREAS, the Board and the Township have entered into a Shared Services Agreement by which the Township is undertaking the installation of a new turf field ("Turf Field") at the Jefferson Township High School Athletic Complex, and the Board is undertaking the removal, repositioning and replacement of new bleachers and press box at the Athletic Complex, which consists of the football field, track, press box, bleachers and any and all related structures and grounds; and

WHEREAS, N.J.S.A. 18A:20-34 allows a board of education, pursuant to its rules, to permit the use of the grounds and other property of the district, when not in use for school purposes for, among other reasons, the holding of social, civic, and recreational meetings and entertainments and such other purposes as may be approved by the Board; and

WHEREAS, the Township has the need and desire to use the Athletic Complex for recreational activities and Township-sponsored or authorized recreational use, and other related activities and uses; and

WHEREAS, the Board has approved the use of the Athletic Complex by the Township when it is not needed for school purposes for the reasons permitted under N.J.S.A. 18A:20-34; and

WHEREAS, the Board and Township intend to enter into the Agreement for the use of the Athletic Complex for the reasons permitted by N.J.S.A. 18A:20-34.

NOW THEREFORE, in consideration of the mutual covenants, conditions and Agreements contained herein, the Board and Township agree as follows:

1. RECITALS.

The above recitals are incorporated into the Agreement.

2. TERM.

The term of the Agreement shall be for ten (10) years. In the event that the parties agree that the Turf Field is still usable at the end of the ten (10) year term, this Agreement shall automatically be extended until such time that the Turf Field needs to be replaced ("Term"). This Agreement shall become effective upon the Township's successful completion of the installation of the turf field at the High School.

3. USE.

The Township's use and access to the Athletic Complex shall be governed by the Board's use policy governing the Athletic Complex. All school sanctioned events shall be given priority with respect to use of the field. When the Athletic Complex is not needed for school sanctioned events, the Township will have primary use over the Athletic Complex. It is expressly understood that the Township's intent is to use the Athletic Complex for recreation department sponsored games and practices.

4. MAINTENANCE.

The Township agrees to provide routine maintenance to the Turf Field surface. Any maintenance, repair other than routine maintenance will be split 50%.

5. INDEMNIFICATION.

Township agrees to indemnify and save Board, collectively and individually, harmless from and against any and all liability, and any and all loss, cost and expense, including, but not limited to, reasonable attorney's fees, arising out of the Township's use, operation, maintenance, management and control of the Athletic Complex or in connection with (i) any and all loss, injury or damage whatsoever incurred by the Board or claims made against the Board arising out of the Township's, or its licensee's, invitee's or permitee's negligence or use of the Athletic Complex, (ii) any and all breach of the Agreement by Township, (iii) any and all acts or omission of the Township, or of any person on the Athletic Complex, occurring in, on or about the Athletic Complex while same is being used by the Township, its licensees, invitees or permitees.

The Board shall have a reciprocal indemnification obligation to the Township as the Township has to the Board.

(a) The Board shall provide casualty insurance for the turf upon delivery of the material and throughout the life of the field.

6. LIGHTS

The Township will install a mechanism for the remote operation of the field lights. The Board will assume the cost of lighting the field for seven years. After the initial 7 year period the Township will reimburse the Board for the cost of electricity for the lights incurred during the Township's use, or Township sponsored use, of the Athletic Complex.
