L.3 Motion to adopt the **New Jersey Civil Unions Resolution**: (copy available for review)

Whereas the State of New Jersey has enacted the "New Jersey Civil Union Act" which provides that civil union couples shall have all the benefits, protections and responsibilities under law, whether they derive from statute, administrative or court rule, public policy, common law or any other source of civil law, as are granted to spouses in a marriage; and

Whereas the New Jersey Department of Education has informed New Jersey school districts in an attempt to ensure consistency with regard to all of the provisions in the statutory law concerning marriage and spouses and the rights and benefits thereof, the Civil Union Act provides whenever a law, rule, regulation, judicial or administrative proceeding or otherwise reference is made to "marriage," "husband," "wife," "spouse," "family," "immediate family," "dependent," "next of kin," "widow," "widower," "widowed," or another word which in specific context denotes a marital or spousal relationship, the same shall include a civil union; and

Whereas the New Jersey Department of Education has informed New Jersey school districts the New Jersey Department of Education will be recommending to the New Jersey State Board of Education that it amend all references in Titles 6 and 6A of the Administrative Code to substitute "marriage/civil union" for "marriage", "spouse/civil union partner" for "spouse", etc. and at which time the Board of Education will revise applicable Board Policies; and

Now, therefore be it resolved, the Jefferson Township Board of Education will ensure compliance with both the letter and the spirit of the law until the State Board of Education amends all references in New Jersey Administrative Code 6 and 6A to substitute "marriage/civil union" for "marriage", "spouse/civil union partner" for "spouse", etc.; and

Be it further resolved, the school district administrative staff will review any forms the district utilizes and make the necessary changes in any references to marital or spousal relationship, e.g. from "married" to "married/civil union" or from "spouse" to "spouse/civil union partner," etc. so there are no separate choices on any forms.
