- **Policy and Personnel Committee** – Mrs. Castiglione addressed the coaching framework and policies as discussed at the last Committee meeting. Also discussed was the role of the Committee agenda items and how issues and concerns filter to specific committees.
- **Building Needs and Finance Committee** – Mr. Anzano noted the Committee has recommended Pomptonian as a food service provider. The Committee also reviewed the technology upgrades available to the district, sports bids results, athletic program options, pay-to-participation options and a request from Jefferson Child Care to place a trailer on district property. Discussion also took place as to the 2009-2010 budget and year-end balances. It was noted that the Committee requested further clarification of the athletic budget totals.

2. These matters will be disclosed to the public as soon as the need for confidentiality no longer applies.
3. This resolution shall take effect immediately.
